### General Instructions:


1. Fee will be accepted without late fee from **October 11, 2019 to October 31, 2019 between 8.00 am to 12.30 pm**
2. Fee will be accepted only by **DD/CTS Cheques** in favour of:-  
**“BHARATIYA VIDYA BHAVAN VIDYASHRAM -II ”**
3. Cheques / DD should bear the **Name of the Student, Scholar Number, Class-Section and Telephone number** of the drawer on its back. If cheque is dishonoured by bank due to any reason (**insufficient funds, signature not matching, no date, no initials etc.**) **Rs. 1000/-** will be charged extra.
4. **Fee can be paid through ERP/ School Mobile app from our payment gateway.**
5. Parents can also drop the fee cheque (of any class) in the cheque collection box at the reception between 8.00 am to 3.00 pm on all working days up to **October 31, 2019** afternoon only (**School Fee**). The receipt of the above cheque will be sent through your ward by the Class teacher.

Parents are requested to kindly adhere to the time schedule and avoid inconvenience.

**Note: As Civil Writ Petition 8959/2018 is still pending in the Hon'ble High Court the above fees is subject to the final outcome of the writ petition.**
